(Initial) I further understand and hereby authorize the Tomball Police Department to make any investigation of my personal history deemed necessary for consideration to attend the Citizens Police Academy. I understand that this background investigation may include, but is not limited to criminal history, employment history, and personal references.

(Initial) I understand that if I am a Texas Concealed Handgun License holder or become licensed during the course of the academy, I will not carry any weapon(s) into class, or to any Citizens Police Academy or Citizens Police Academy Alumni Association function. I understand that to do so is cause for immediate dismissal from the program.

(Initial) I further state that I have never been convicted of any violent felony offense, family violence assault, narcotics violation, or weapons offense, nor have I been convicted of any crimes of moral turpitude or non-violent felony offense. I further attest that I am not currently under indictment for any offense, nor do I knowingly associate with any individuals whom I believe to be convicted of, under investigation or indictment for any felony, not excluding narcotics, weapons, or assault offenses, by any law enforcement agency. I understand that I may be dismissed from the academy if my behavior is deemed disruptive or if it otherwise inhibits the concept of this Citizens Police Academy.

(Initial) I, the undersigned _____, a private person, for and in consideration of the privilege of participating in the Tomball Citizens Police Academy, and in recognizing that such activity involves certain inherent dangers do hereby agree to assume the risks attendant to such activity, to include motor vehicle accidents on either public streets or private property, and do hereby release the City of Tomball, its officer, agents, representatives and employees, in both their public and private capacities, from any and all liability claims, suits, demands, damages, including attorney's fees, or causes of action, for any and all claims, personal injury or property damage, that I, or my heirs, successors and assigns may have or may hereafter acquire against the City of Tomball, including but not limited to 1) motor vehicle accidents on public streets or private property, 2) personal injury or property damage that may arise from the acts of a third person, 3) personal injury or property damage that may arise from the negligent acts of the City of Tomball, its officer, agents, representatives, or employees relative to my participation in the Tomball Police Department Citizens Police Academy, and/or 4) wrongful death claims.
